The Life of Mine area would increase from 105 acres to 154 acres, located on State Route 30, in the Town of Middleburgh, may have a significant effect on the environment and that a Draft Environmental Impact Statement (DEIS) must be prepared.

This notice is issued pursuant to Part 617 of the implementing regulations pertaining to Article 8 (State Environmental Quality Review Act) of the Environmental Conservation Law.

The New York State Department of Environmental Conservation, as Lead Agency, has determined that the proposed action described below may have a significant effect on the environment and that a Draft Environmental Impact Statement will be prepared.

Description of Action:

Carver Sand and Gravel, LLC, is proposing to expand an existing permitted hard rock quarry by adding an additional 49 acres to the existing 105 acre Life of Mine area. The Life of Mine area would increase from 105 acres to 154 acres. The 49 acre expansion area will be located approximately 1000 feet east of and approximately 290 feet higher than the existing approved Life of Mine.

A portable primary crusher will be located on the quarry floor of the proposed expansion area behind a ridge of unexcavated stone along the west side of the proposed modification area.

An existing woods road will provide vehicle access to the modification area. A stone-lined ditch and other storm water control features and a conveyor will be built along the access road. Rock from the expansion area will be moved by the conveyor from the primary crusher to the existing processing plant in the existing quarry. Transporting the rock by the conveyor is a quieter and more efficient process than moving the rock by trucks.

Reasons Supporting this Determination:

The primary potential impact associated with the mine expansion is visual. The 49 acre mine expansion represents an expansion by approximately 46%. This expansion has the potential to have adverse visual impacts on the viewshed areas located primarily to the northwest, west and southwest of the mine due to the expansion area being located approximately 1,000 feet east of and 290 feet higher in elevation than the existing quarry.
